Since joining Schellenberg Wittmer in January 1996, Mr Geisinger's practice has focused primarily on international commercial arbitration. He has acted as counsel and arbitrator in complex commercial disputes involving international construction contracts, consortia and joint venture agreements, sponsorship contracts, sales and distribution contracts, post-M&A disputes, consultancy contracts and hotel management contracts. Recently, he has also advised a major Swiss corporation in connection with an international investment protection matter. Mr Geisinger has also participated in drafting arbitration rules for commercial arbitration and for sports arbitration.

Mr Geisinger has also represented parties before Swiss courts in arbitration-related court proceedings, such as judicial appointments of arbitrators or challenges of arbitral awards before the Swiss Supreme Court. Several cases in which Mr Geisinger represented parties before the Swiss Supreme Court have been reported in the official collection of Swiss Supreme Court cases and in specialized journals.

Mr Geisinger is President of the Swiss Arbitration Association ("ASA") since 2014, having previously been Vice-President from 2010 to 2013. In 2014, Mr Geisinger was elected as a member of the Board of Trustees of FIAA (Foundation for International Arbitration Advocacy).

In addition to his activities in international commercial arbitration, Mr Geisinger advises clients on aspects of international civil litigation, in particular enforcement in Switzerland of foreign judgments and on cases often involving complicated issues of private international law related to contract, tort and inheritance law. Mr Geisinger's practice also includes legal opinions on Swiss substantive law, in particular contract law, and court litigation in Geneva in commercial and contractual disputes.

A particular area of specialization is construction, including contract management in large-scale construction projects. Mr Geisinger has led contract-management teams for an Italian general contractor in connection with the construction in Switzerland of a large pharmaceutical plant and for the extension and revamping of an oil refinery, for a Swiss general contractor in connection with the renovation of a 5-star hotel in Switzerland, for a Swiss owner in relation with the construction of a major R&D facility in Switzerland and for a Turkish contractor in connection with the construction of a hotel in a Central Asian country.

Prior to joining Schellenberg Wittmer, Mr Geisinger was an associate at Etienne Blum Stehlé Manfrini & Partners (Baker & McKenzie) in Geneva, where he had the same fields of practice. Before admission to the bar, Mr Geisinger gained extensive knowledge of Swiss private international law as a teaching and research assistant to Professor Pierre Lalive at the Department of private international law of the University of Geneva.
